UPMC is proud to support the official launch of a new Maternal Child Health Program in Clinton County, in partnership with Pennsylvania's Department of Health (DOH). This program will expand and ensure access to high-quality maternal health care in Clinton County by providing a front door for pregnancy testing and prenatal education provided by the Lock Haven State Health Center and connecting patients with needed care at UPMC Lock Haven and UPMC Williamsport.

"Our goal is simple: to develop a local network that provides easier access to basic pregnancy and post-partum care services that support mothers, babies and families. This pilot project is the latest effort in the [Shapiro] Administration's ongoing work with health care and community leaders, to find commonsense solutions to support and sustain our rural health care system," said Debra Bogen, MD, Pennsylvania Secretary of Health.

The partnership was marked on Jan. 28 by a Community Baby Shower to celebrate the program's launch. The event provided car seat safety checks, educational materials, and other giveaways for community members.

"I am hopeful that [the] event will showcase an innovative model of care and inspire others to adopt similar approaches across the state," said Patti Jackson-Gehris, UPMC in North Central Pennsylvania President. "We are grateful to be able to partner with the state in support of this pilot program. [It] is just the beginning of a larger, ongoing dialogue aimed at developing sustainable solutions to ensure every woman has access to the care she deserves."
