## **Colon and Rectal Procedures**

- Minimum Formal Training: successful completion of an approved residency training program in colon and rectal surgery by the American Board of Colon and Rectal Surgery or the American Osteopathic Board of Surgery
- Board Certification: Current certification or active participation in the examination process leading to certification in colon and rectal surgery by the American Board of Colon and Rectal Surgery or the American Osteopathic Board of Proctology
- Required Previous Experience: Documentation of the performance of at least 50 colon and rectal surgery procedures in the past two (2) years or successful completion of a hospital-affiliated formalized residency or clinical fellowship in the past two (2) years

**Colonoscopy**- Residency or fellowship training or documentation of 50 cases within the last two (2) years

<u>Flexible Sigmoidoscopy</u>- Residency or fellowship training or documentation of 25 cases within the last two (2) years

**Snare Polypectomy**- Residency or fellowship training or documentation of 15 cases within the last two (2) years

<u>Tumor Ablation</u>- Residency or fellowship training or documentation of 5 cases within the last two (2) years

<u>Administration of Conscious Sedation</u>- Current ACLS, ATLS, PALS, or BLS for Healthcare Providers
