Definitions and Qualifications

Routine testing is not necessary for low risk procedures unless deemed necessary by the physician
 Low risk procedures: Superficial lesions, cataract surgery, most finger surgery, carpal tunnel release, colonoscopy, cystoscopy, and myringotomy.
 Moderate risk procedures: Most surgeries requiring general/regional anesthesia including laparoscopy, hernia repair, shoulder surgery, and most orthopedic surgery.
 High Risk procedures: Cardiac surgery, neurosurgery, colonic resection, lung/thoracic surgery.
